

Reminder that all dogs are required to be on leashes in both Dallas and Collin Counties. It doesn't matter how well-trained you think your dog is—it's the law. And hey, if this guy can do it, can't we all?

Trash Receptacles

As a friendly reminder, please ensure all trash and recycle containers are only out for trash/recycle collection days. On all other days, they must be hidden from public view, in accordance with the Conditions, Covenants and Restrictions (CCRs) for University Place Dallas. The specific language is below. Without a structure to hide receptacles from view, they can not be stored outside your garage or fenced yard.

3.16 Trash Receptacles and Collection. Each Lot Owner shall make or cause to be made appropriate arrangements with the City for collection and removal of garbage and trash on a regular basis. Each and every Owner shall observe and comply with any and all regulations or requirements promulgated by the City and/or the Association in connection with the storage and removal of trash and garbage. All trash, garbage, or waste matter shall be kept in tightly sealed bags or other approved containers that shall be maintained in a clean and sanitary condition. An Owner may place trash on the street curb or access easement only on those days designated by the City as trash collection days. On all other days, an Owner must keep all trash, garbage and other waste material hidden from public view. No Lot shall be used for open storage of any materials whatsoever, except that building materials to be used in the construction of improvements erected on any Lot may be placed upon such Lot at the time construction is commenced and may be maintained thereon through completion of construction. No garbage, trash, debris, or other waste matter of any kind shall be burned on any Lot.







Our Dallas City Council Member, Cara Mendelsohn, provided an update on DART's plans for Coit Road in September (see excerpts below). We have engaged an attorney for the HOA and individual homeowners closest to Coit Road are also organizing. Reach out to DART committee chair, Sarah Weyandt, for more information. From the District 12 e-news:

If you live near DART's Cotton Belt/Silver Line tracks and you do not have an attorney, you may want to consider engaging one to protect your interests. DART is openly talking about NOT following the ILA with the city.

COIT ROAD - DART is still pursuing a design that does not meet the Interlocal Agreement (ILA), and will create a more dangerous situation for the 55,000 daily vehicles and a lasting negative visual impact for those who live near Coit Road. The point of contention is how far down the rail will go below the street. The ILA says 11' but DART wants to go 8'. This means there will be a bigger "hump" on the roadway, making traffic less safe, providing less privacy, more noise, and an ugly road outside the windows of Highland Springs and University Place residents. There is land DART needs to acquire that may also delay the construction on Coit. DART says the ILA measurement didn't specify if it would be 11' to top of rail (customary) or bottom of rail. I hope DART will honor what they told the community and redesign Coit to meet the agreement.

IMPORTANT: Rumors are that DART will ask the City Council to revise the ILA to suit their needs. Possibly, they will leverage the \$100 million excess sales tax they received and should be returning to the city to pressure the city council to approve changes to the ILA. If you live in the area, you may want to consider hiring an attorney to represent your interests. At least two attorneys are working on a contingency basis, so there are no out of pocket expenses for residents. Residents are giving each other referrals on Next Door and in Facebook groups on this subject. The Facebook group Neighbors Sharing Cotton Belt Information is a good source for questions or referrals.

The 2023 Budget should be finalized by November. Keep an eye on your email as Essex will be sending out a notice to announce the next Town Hall and Elections for the Board. We will be able to elect five resident board members with one of the five residing in the townhomes, the email from Essex will outline the election process and timeline. The results will be shared at the HOA Town Hall tentatively in November.

Also remember that the annual assessment will be posted to your account on January 1st and is due no later than January 31st.
